### NOTIFICATION


In exercise of the powers conferred by section 164 of the Tripura State Goods and Services Tax Act, 2017 (Tripura Act No. 9 of 2017), the State Government hereby makes the following rules further to amend the Tripura State Goods and Services Tax Rules, 2017, namely:-

1. (1) These rules may be called the Tripura State Goods and Services Tax (Seventh Amendment) Rules, 2018.  
(2) Save as provided in these rules they shall be deemed to have come into force.
  2. In the Tripura State Goods and Services Tax Rules, 2017, -
    - (i) with effect from 12<sup>th</sup> June, 2018, in rule 125, for the words "Directorate General of Safeguards", the words "Directorate General of Anti-profiteering" shall be substituted;
    - (ii) with effect from 12<sup>th</sup> June, 2018, in rule 129, for the words "Directorate General of Safeguards", wherever they occur, the words "Directorate General of Anti-profiteering" shall be substituted;
    - (iii) with effect from 12<sup>th</sup> June, 2018, in rule 130, in sub-rule (2), for the words "Directorate General of Safeguards". at both places where they occur, the words "Directorate General of Anti-profiteering" shall be substituted;
    - (iv) with effect from 12<sup>th</sup> June, 2018, in rule 131, for the words "Directorate General of Safeguards", the words "Directorate General of Anti-profiteering" shall be substituted;
    - (v) with effect from 12<sup>th</sup> June, 2018, in rule 132, in sub-rule (1), for the words "Directorate General of Safeguards", the words "Directorate General of Anti-profiteering" shall be substituted;

- (vi) with effect from 12<sup>th</sup> June, 2018, in rule 133, for the words “Directorate General of Safeguards”, wherever they occur, the words “Directorate General of Anti-profiteering” shall be substituted.
- (vii) with effect from 13<sup>th</sup> June, 2018, in rule 133, in sub-rule (3), in clause (c), for the words “Tripura Goods and Services Tax Act, 2017”, the words “Central Goods and Services Tax Act, 2017” shall be substituted.
