**1. Amendment of Schedule II (a):**

- (a) The description of goods in entry no. **25** is deleted.
- (b) The rate of tax is enhanced from 4% to 5% on the declared goods under entry no. **35**.

**2. Amendment of Schedule VIII:**

The rate of tax is enhanced from 4% to 5% for all items under **Schedule VIII**.
