In order to keep uniformity for issuing Registration Certificate by the Charge offices under the Tripura Road Development Cess Ordinance, 2018 (Tripura Ordinance No. 2 of 2018) read with rule 5 of the Rules made thereunder, all the Superintendents of Cess of the Charge offices are hereby directed to follow the following for issuing Registration Certificate.

- the dealers under the Tripura Road Development Cess Ordinance, 2018 (Tripura Ordinance No. 2 of 2018) would be "XYZ/Name of the Charge/TRD Cess/Year of Registration" (XYZ means Running serial Number of registrant starting from 001 irrespective of year of registration, Name of the Charge means name of the concerned charge in short form, TRD Cess means the Tripura Road Development Cess and Year of Registration means the calendar year when the registration certificate is issued).
- (ii) Short form of the Charges to be indicated in the registration certificate would be as under:
