**MEMORANDUM**

The Memorandum issued vide No.VIII-1(1)/TAX/MISC(P)/4579-604 dated 30.05.2012 in respect of registration of dealers under TVAT Act & CST Act and registration of transporters under the TVAT Act, 2004 and also amendment of registration certificates under the TVAT Act and CST Act for Agartala Charge - I to VIII has been reviewed and it is felt necessary to roll back to the previous system for granting registration and amendment of registration certificates of the dealers / transporters by the concerned charge.


2. Therefore, it is decided that henceforth the entire process of registration of dealers under the TVAT Act & CST Act and registration of transporters under the TVAT Act and also amendment of registration certificates under the TVAT Act & CST Act for Agartala Charge-I to Charge-VIII shall be made by the respective charge as these were done previously.

3. The Superintendent of Taxes, Registration Cell shall return all the pending files relating to issue of registration and amendment of registration certificates to the concerned charges immediately.

4. The IT Nodal Officer of this Organisation shall make necessary arrangement in the VATSoft application for enabling the Superintendent of Taxes, Charge-I to Charge-VIII, Agartala to perform the entire process of registration of dealers and transporters and amendment of registration certificate under their charges as done in other charges outside Agartala.

5. All concerned are directed to follow the above instructions strictly.


