## MEMORANDUM

Sub: Furnishing of list of Hotels, Restaurants & Caterers who are liable to pay tax on the item "ready to serve foods and food preparations including instant foods etc."

The items ready to serve foods and food preparations including instant foods etc. are taxable @ 13.5% under entry no. 70 (i) of Schedule II (b) of the Tripura Value Added Tax Act, 2004. Most of the Hotels, Restaurants & Caterers dealing in the said items will have annual taxable turnover exceeding Rs. 3.0 Lakhs and therefore liable for VAT Registration and payment of tax.

- 2. In the monthly meeting held on 23<sup>rd</sup> June, 2012, the matter was discussed and it had come to light that most of the Hotels, Restaurants & Caterers are not registered under the TVAT Act. Therefore, action needs to be taken by all the Superintendents of Taxes for bringing such Hotel, Restaurants & Caterers under VAT net.
- 3. All the Superintendents of Taxes of Charge Offices are directed to conduct survey within their jurisdiction and identify the Hotels, Restaurants & Caterers who are liable to get registered under the TVAT Act. The list in the prescribed format at Annexure shall be submitted to this end by 05<sup>th</sup> July, 2012 positively.
