NOTIFICATION


In exercise of the powers conferred by section 164 of the Tripura State Goods and Services Tax Act, 2017 (Tripura Act No. 9 of 2017), the State Government hereby makes the following rules further to amend the Tripura State Goods and Services Tax Rules, 2017, namely:-

1. (1) These rules may be called the Tripura State Goods and Services Tax (Seventh Amendment) Rules, 2018.
 - (2) Save as provided in these rules they shall be deemed to have come into force.
 2. In the Tripura State Goods and Services Tax Rules, 2017, -
 - (i) with effect from 12th June, 2018, in rule 125, for the words "Directorate General of Safeguards", the words "Directorate General of Anti-profiteering" shall be substituted;
 - (ii) with effect from 12th June, 2018, in rule 129, for the words "Directorate General of Safeguards", wherever they occur, the words "Directorate General of Anti-profiteering" shall be substituted;
 - (iii) with effect from 12th June, 2018, in rule 130, in sub-rule (2), for the words "Directorate General of Safeguards", at both places where they occur, the words "Directorate General of Anti-profiteering" shall be substituted;
 - (iv) with effect from 12th June, 2018, in rule 131, for the words "Directorate General of Safeguards", the words "Directorate General of Anti-profiteering" shall be substituted;
 - (v) with effect from 12th June, 2018, in rule 132, in sub-rule (1), for the words "Directorate General of Safeguards", the words "Directorate General of Anti-profiteering" shall be substituted;

- (vi) with effect from 12th June, 2018, in rule 133, for the words "Directorate General of Safeguards", wherever they occur, the words "Directorate General of Anti-profiteering" shall be substituted.
- (vii) with effect from 13th June, 2018, in rule 133, in sub-rule (3), in clause (c), for the words "Tripura Goods and Services Tax Act, 2017", the words "Central Goods and Services Tax Act, 2017" shall be substituted.
