**NOTIFICATION**


With the implementation Mission Mode Project for Computerization of Commercial Taxes (MMPCT) a Notification vide No.F.1-7(8)/TAX/MISC/2011 dated 20<sup>th</sup> September, 2011 was issued by the Commissioner of Taxes, Government of Tripura, Finance Department to introduced new system of Electronic payment of taxes namely, e-Payment of taxes for the dealers in Taxes & Excise Organisation, Finance Department, Government of Tripura. In pursuance of that it is decided by the State Government that the Accounts Rendering Unit for the purpose of e-Payment of taxes shall be **Agartala Treasury-I**. This will be single point treasury for all payments with bank in electronic mode through online or internet banking in Tripura.

2. In addition to the role the Accounts Rendering Unit is expected to perform under the said notification, Agartala Treasury-I shall have following duties.

- (a) It shall reconcile the receipt of taxes on daily basis with the Nodal Officer of the Taxes & Excise Organisation appointed for this purpose.
  - (b) It shall send bank wise daily reports through NIC e-Mail about the details of the e-Payment of taxes to the official e-Mail account of the Commissioner of Taxes & Excise based on the information received from bank(s).
  - (c) It shall maintained e-Scroll Serial Number separately in their system in case of e-payment.
  - (d) It shall enter remittance number, date and amount day wise in the VATSoft accessible through **www.tripurataxes.nic.in** website as well as send bank wise daily reports through NIC e-Mail about the details of the e-Payment of taxes to the official e-Mail account viz. **agtry1-tr@nic.in**.

- (e) Any other process which will be required for smooth implementation of the system of e-Payment of taxes.
3. The Nodal Officer, e-payment, shall reconcile the figures obtained from treasury, bank with the data available in the VATSoft on daily basis.
4. For the purpose of e-payment of taxes, the Deputy Commissioner of Taxes (DDO Code 08300) shall be taken as Drawing and Disbursing Officer (DDO) for all receipts of taxes.
