In exercise of the powers conferred by sub-section (1) of section 11 of the Tripura State Goods and Services Tax Act, 2017 (Tripura Act No.9 of 2017), the State Government, on being satisfied that it is necessary in the public interest so to do, on the recommendations of the Council, hereby makes the following further amendments in the notification of the Government of Tripura, Finance Department, No.12/2017- State Tax (Rate), dated the 29thJune, 2017, published in the Tripura Gazette, Extraordinary Issue, *vide* number 233, dated the 29th June, 2017, namely:-
