**NOTIFICATION**

In exercise of the powers conferred by Section 34 of the Tripura Road Development Cess Act, 2018, the State Government hereby makes the following rules to further amend the Tripura Road Development Cess Rules, 2018 (herein after referred as Principal Rules), namely:

**1. Short Title and commencement:**

- (1) These rules may be called the "Tripura Road Development Cess (5<sup>th</sup> Amendment) Rules, 2021";
- (2) They shall come into force on such date, as the State Government may by notification in the Official Gazette, appoint.

**2.** In rule 11 of the Principal Rules, the expressions "**for which any return is required to be furnished**" shall be *deleted*.

**3.** In sub-rule (1) of rule 13 of the Principal Rules, the expressions "**each month**" shall be substituted by the expressions "**the year**".

**4.** In sub-rule (3) of rule 13 of the Principal Rules, the expressions "**a copy**" shall be substituted by the expressions "**a copy or copies**".


